the new City garage and build a new Fire Station. Cindy will
continue with getting estimates for new building(s) along with a
business plan from Pappa Johns Center.

City Maintenance Report:

- Steve will be getting together with Ron to order new flags for the Community Center.
- Steve met with Heartland in regards to resurfacing the tennis courts.
- Steve has been working on the Christmas Decorations on Main Street.
- Copper line by the recirculating pump at the Water Plant has broken and has been replaced.
- Steve has sent eight tests in for the draw down at the lagoon.
- Nitrate test was missed. Customers will be receiving more information in their monthly water bills. Steve is working with Warren to create a schedule for testing.
- The park and lagoon have been sprayed for herbicides.
- Penny motioned, Cindy 2nd to approve the City Maintenance report. Unanimous

Mayor's Report:

- Street lights replaced on main.
- Nick checked with ICAP insurance in regards to making Winnebago River a water trail access. The city is not liable for water activity and has coverage on the dam. *Tad motioned, Ron* 2nd to send a letter of support. Unanimous.
- City of Fertile has Umbrella Policy for \$2 million. Ron mentioned increasing this to \$5 million. Nick will get estimates.
